Jason Mutterer, principal at Arlington Summit High School, was preparing for graduation. Like most in charge, he wanted to make it special, but his imagination, a not-so-simple act of kindness, will live in the hearts and memories of not only the graduates, but also their parents.

Mutterer took the time to write an individual, heartfelt note to all 443 graduates. Included was a \$1 bill. Each note took around 15 minutes and included a specific thank you, nicknames and references only a caring person would know.

At the ceremony, the students were to his back, on a stage. When the principal, a former coach, started his speech, he turned his back on the audience and directly addressed his students. They were made to feel even more special.

One student, Eduardo Estrada told NBC "He knows almost everybody by name. He knows something going on in everybody's lives." Priceless!

Why include a dollar, which most consider insignificant?

Mutterer has a different view. In the same interview, he said, "'If 443 kids are doing random acts of kindness

every day, it has a huge, huge impact on our society.""

Daniel Ezenagu told NBC Dallas-Fort Worth, "'Athletes, bands, regular students—whatever you do, he knew about it." In Mutterer's note to Daniel, he referred to him as "Dan the Man."

So, what can you do as the start to the school year is around the corner? Continue to make a difference, share the story, initiate random acts of kindness, and encourage others to work on stopping the hate that is spreading throughout this country.

After all, isn't that what great educators already do!

For new members, it's the beginning of a chapter of your life, one which hopefully brings happiness and fulfillment. As a student, teacher, parent, grandparent and union representative, most of my life has revolved around the school calendar. I reflect on childhood memories of shopping for supplies—a new box of crayons with the sharpener built into the box, bright, squeaky gym shoes and maybe an outfit or two. As a teacher, I recall decorating my classroom, making seating charts and creating lesson plans to engage the young minds of those who entered my classroom. There are other ways we, as a nation, need to get "back to school." As educators, we face many challenges. We strive to meet the needs of our students and inspire them to learn. We make do with available resources. We work hard and fight for the pay and working conditions we deserve. This has all been true from my earliest school experiences. Nowadays, we face additional challenges. Public education is under attack. A federal voucher program will divert more public funds to private schools this year than ever before. The false narrative of "failing public schools" is playing loudly, nationwide. Our unions are under attack by billionaires who want education to become a for-profit industry. Our Tier 2 members face a future with an inadequate pension that structurally guarantees they will fall further behind in each year of retirement. Insufficient higher education funding feeds drastically rising tuition, putting opportunities out of reach for many.

As a union of educators, we must stand up to these challenges. We must turn our nation's priorities "back to school." We must advocate for adequate funding for our public schools, colleges and universities. We must continue the fight for improvements to the Tier 2 pension systems. And we must fight against the diversion of public dol-



lars to private institutions. The state of Illinois needs revenue solutions that end the reliance on property tax increases and do not add to the tax burdens of the middle class. Each of us as individuals can do only so much. We can face these challenges better as a union, working together in strength and solidarity. And that is exactly what we intend to do.

The start of the new school year brings new treasurers for some of our councils. Keeping that in mind it is time to remind all treasurers of things that need to be taken care of beginning in September.

#### Monthly Checks and Balances

Be sure you balance your checkbook and receipts with your bank statement each month. Additionally, you need to make certain you have itemized receipts to coincide with expenditures. These receipts should be stapled to your monthly reconciliation sheet and kept in a monthly file. You do not need to send copies of the reconciliations or bank statement to our office.

#### Council Audit 2024-2025

It's time once again to complete your 2024-2025 council audit. All council presidents and treasurers received a memo detailing the directions for completing the audit. Make certain your audit committee gets a copy of the memo detailing the process for doing the audit and that they follow the directions that were highlighted. Please try and get this audit completed as soon as possible. The deadline for filing the completed audit with AFT Local 604 is November 15, 2025.

#### **Council Dues Payments**

At the end of each month, you need to complete and submit to AFT Local 604 the monthly dues remittance along with your payment. The forms are provided for your use throughout the school year. Remember, dues are paid over ten months from September through June of each school year. When submitting dues, please remember to fill in the number of members and do not staple the check to the remittance slip. Make all checks payable to AFT Local 604.

The Local now accepts dues payments electronically via ACH transaction. Payments can be made directly from bank to bank. For more information on this, please see your President/Treasurer packet or call me at the office 815/725-0402.

For members who begin employment after the start of the school year, their level of dues payment IS NOT based on how much they will earn in the amount of time they work. Their level of dues payment IS based on how much they would earn if they had worked the entire year.

#### Council Rosters

Along with each dues remittance payment, our office needs a roster of all members. The information needed for each person on the roster is their first and last name, address, employee number, and dues deduction (level of dues payment.) This is needed in an Excel format. By having it in the Excel format, it can be easily merged with our database therefore avoiding errors in our membership database.

#### 990 Filing

It is the time of year again to file 990 forms in order to keep the tax exempt status. Be certain that your council provides me with the appropriate documentation so I can complete the returns by the deadline. Councils that are filing late are subject to a daily fine for each day the form is late. Information regarding the filing requirements for the 990 forms and the council's deadline for filing, based on the end of your fiscal year, has been sent to council presidents and treasurers.

## Your rights under the Workers' Compensation Act

## Welcome Back!

A s you begin the 2025–2026 school year, you are welcomed back with pride, purpose, and deep gratitude for the vital work you do every day. Whether you're preparing classrooms, planning curriculum, or greeting returning students with familiar smiles, please remember you deserve to feel safe, supported, and protected on the job.

This fall, we want to reaffirm one essential message: you have rights under the Illinois Workers' Compensation Act.

Illinois law guarantees that if you suffer a work-related injury or illness—whether it's from a sudden accident or cumulative stress—you are entitled to key benefits, including:

- Medical care for your injury or illness
- Temporary or permanent disability benefits
- Vocational rehabilitation if needed Wage replacement while you recover

#### **Timely Reporting Is Crucial**

If you experience a workplace incident, you must report it to your employer within 45 days. The sooner, the better. Delayed reporting can result in delayed or denied benefits. This includes not only sudden injuries but also repetitive stress injuries and/or worsening joint pain injuries.

#### **Accurately Report Incidents**

Please be sure to accurately report all incidents and be specific to outline defects and details of how the accident occurred. For example, something spilled on the floor, the tiles were broken on the stairs, children were racing down the hallway etc. Be specific on the mechanism of injury too. For example, was it lifting the box that caused ones back to give out or was did it give out while bending down to lift the box. The first is likely a compensable mechanism of injury, the second is likely not.

#### **Seek Immediate Medical Attention**

Do not delay medical treatment. It is important to establish a medical record as soon as possible, not just to confirm the nature of the injury but to also reiterate the history of how the accident or injury occurred.

#### Keep a Record

We encourage you to document all incidents, nearmisses, or unsafe conditions. Put it in writing and notify your supervisor. Your union is here to support you through the reporting process and to advocate for your rights if any concerns arise. If you've already experienced an issue, or are unsure how to proceed, don't wait—reach out to your union steward or contact the Ridge Law Group for review and discussion of your claim.



# Commandments we can live by ...

Louisiana already has a law that requires public schools to post the 10 Commandments in the classrooms.

Then in May of 2025, Texas enacted a law, Senate Bill 10, requiring public schools to display the 10 Commandments in every classroom. In doing so, the documents must be at least 16 x 20 and framed or a poster. Oh, and they must be easy to read!

That last line got me thinking. Would that mean in all languages spoken, not just English? Spanish might well be the main language in some districts. I am sure that would not make Gov. Abbott very happy.

But I digressed. Even though as a former Catholic and raised by nuns in grades 1-8, I am a firm believer of separation of church and state.

Recently, I came across a CNN report with the headline: "The Pope's 10 commandments on climate change." I believe this was one of the final reports from Pope Francis before his death.

In the 184-page document, the Pope called for "cultural revolution" to change our lifestyles. He wrote about topics ranging from technology issues to how many treat the poor. But what caught writer Daniel Burke's attention were the easy steps anyone can follow to stop the "disturbing warming" of the planet.

From his article, I believe professional educators can endorse and use these in the classroom without being challenged by the American Civil Liberties Union.

- 1. **Think of future generations:** "What kind of world do we want to leave to those who come after us, to children who are now growing up?"
- 2. Embrace alternative energy sources: "We know that technology based on the use of highly polluting fossil fuels—especially coal, but also gas—needs to be progressively replaced without delay."
- 3. Consider pollution's effect on the poor: "Touch the hearts of those who look only for gain at the expense of the poor and the earth."
- 4. **Take the bus!** "Many specialists agree on the need to give priority to public transportation."

- 5. **Be humble:** "We are no God. The earth was here before us, and it has been given to us."
- 6. **Don't become a slave to your phone:** "True wisdom. . . is not acquired by a mere accumulation of data which eventually leads to overload and confusion, a sort of mental pollution."
- 7. **Don't trade online relationships for real ones:** "Real relationships . . . now tend to be replaced by a type of internet communication which enables us to choose or eliminate relationships at whim."
- 8. Turn off the lights, recycle and don't waste food: "Environmental responsibility can significantly affect the world around us, such as avoiding the use of plastic and paper, reducing water consumption, separating refuse, cooking only what can reasonably be consumed . . . planting trees, turning off unnecessary lights."
- 9. **Educate yourself:** "There is a nobility in the duty to care for creation though little daily actions, and it is wonderful how education can bring about real changes in lifestyles."
- 10. **Believe you can make a difference:** "We must regain the conviction that we need one another, that we have a shared responsibility for others and the world, and that being good and decent are worth it."

I see all of these points, collectively or individually, as learning experiences to challenge students to understand each one and to add to the list.

Did any of these 10 really hit home with you? For me, it was number 10, especially with all that is going on in our country right now.
